WHAT ARE VOLUNTEER/MENTOR GUIDELINES?

- **A good Volunteer/Mentor is consistent, dependable, interested in making a difference, respectful and appreciative of teachers, students, and is faithful to commitments**
- **Volunteers/Mentors are role models for students in behavior, speech, and dress**
- **When persons are on duty as Volunteers/Mentors, the district requests that they dress in conformity with the teacher's dress code.**
- **Volunteers/Mentors will check in at the front desk upon arrival at the school.**
- **Know and adhere to school district regulations regarding Internet and social use. Silence cell phone during Volunteer/Mentor assignments.**
- **Conversations with students must be positive. Let your conversations demonstrate respect for others, and avoid language that may be perceived as discriminatory, sexist, or offensive.**
- **Off Campus meetings between volunteer/mentor are strictly prohibited unless under the direct supervision of parent/guardian or of a school official.**
- **No communication with students through the use of "electronic media" such as: text messaging, email, video sharing on You Tube, comments posted on the Internet, Twitter, Facebook, Instagram, cell phone communication is strictly prohibited. A Volunteer/Mentor may communicate with the parents of a student about volunteer activities by telephone, cell phone, or email. Upon request, a Volunteer/Mentor to district staff a copy of any email communication sent to a parent regarding volunteer activities.**
- **Students build trusting relationships with Volunteers/Mentors. Resist the urge to promise a student that you will not reveal confidential information to parents or school officials. It may necessary to reveal information to protect the welfare of a student and to protect you from violating the Law. The Law protects the privacy of student information that has been reported. All student information during the course of your service must be kept confidential pursuant to FERPA. Sharing student information with others may be a violation of the Law. This identifiable information includes, but not limited to:**
 - **Student's Name**
 - **Parent or Guardian Names**
 - **Names of other family members**
 - **Parent's address**
 - **Health Records**
 - **Discipline or behavioral incident information**
