ACTION ITEM

SUBJECT: Discuss and Consider Action to Approve stadium field renovations

ADMINISTRATOR RESPONSIBLE: Dr. Elmer Avellaneda, Superintendent of Schools, Gene Kridler, Executive Director of Operations

RATIONAL SUMMARY: Field evaluations were completed and pricing was received from Texas Multi-Chem to improve the safety, maintenance, and playability of the natural grass field at Apache Stadium. Work can begin June 2024 and is expected to be completed in August 2024 if Awarded. The two options were: Option 1 for 498,400 and Option 2 was 348,000.

Proposed renovations include removal of existing grass, adding topsoil, regrading, new irrigation system, and rolled sod installation. This item will be funded from fund balance and will utilize the BuyBoard Purchasing Cooperative if awarded.

SUPERINTENDENT'S RECOMMENDATION: We recommend approval of stadium field renovations in the amount of (Option 1-\$498,400 or Option 2-\$348,000) as presented and authorize the Superintendent to negotiate the final terms of the agreement.

SUBJECT: Discuss and Consider Action to Approve the Purchase of Fencing to be Installed Districtwide

ADMINISTRATOR(S) RESPONSIBLE: Dr. Elmer Avellaneda, Superintendent of School; Erin Lindemann-LaBuhn, Executive Director, State and Federal Programs

RATIONAL SUMMARY:

As a component of the Texas Education Agency School Safety Compliance Requirements (19 TAC 61.1031), Gonzales ISD has procured a quote from Foster Fencing (through the BuyBoard Purchasing Cooperative) in order to install TEA-approved safety fencing on all campuses and around additional district facilities such as Apache Field.

This purchase requires board action since the total cost exceeds \$75,000.

The cost of this purchase has been allocated in the Safety and Facilities Enhancement Grant (SAFE), and the SAFE Grant, Cycle 1. If approved, the goal is for this project to begin this summer.

PROPOSED REVISIONS

**Children of District
Employees and
Board Members**

The District shall offer prekindergarten at no cost for children **and grandchildren** of District employees **and Board Members** not otherwise eligible under state law for free prekindergarten, regardless of District residency status.

**Tuition-Supported
Program**

On a space-available basis and in accordance with administrative regulations, the District shall allow other four-year-old children who are not eligible under state law for free prekindergarten to enroll in a tuition-supported prekindergarten program.

To be admitted, a student shall be four years of age by September 1 of the school year of enrollment.

The tuition rate shall be established annually by the Board in accordance with statutory restrictions. [See EHBG(LEGAL)]
